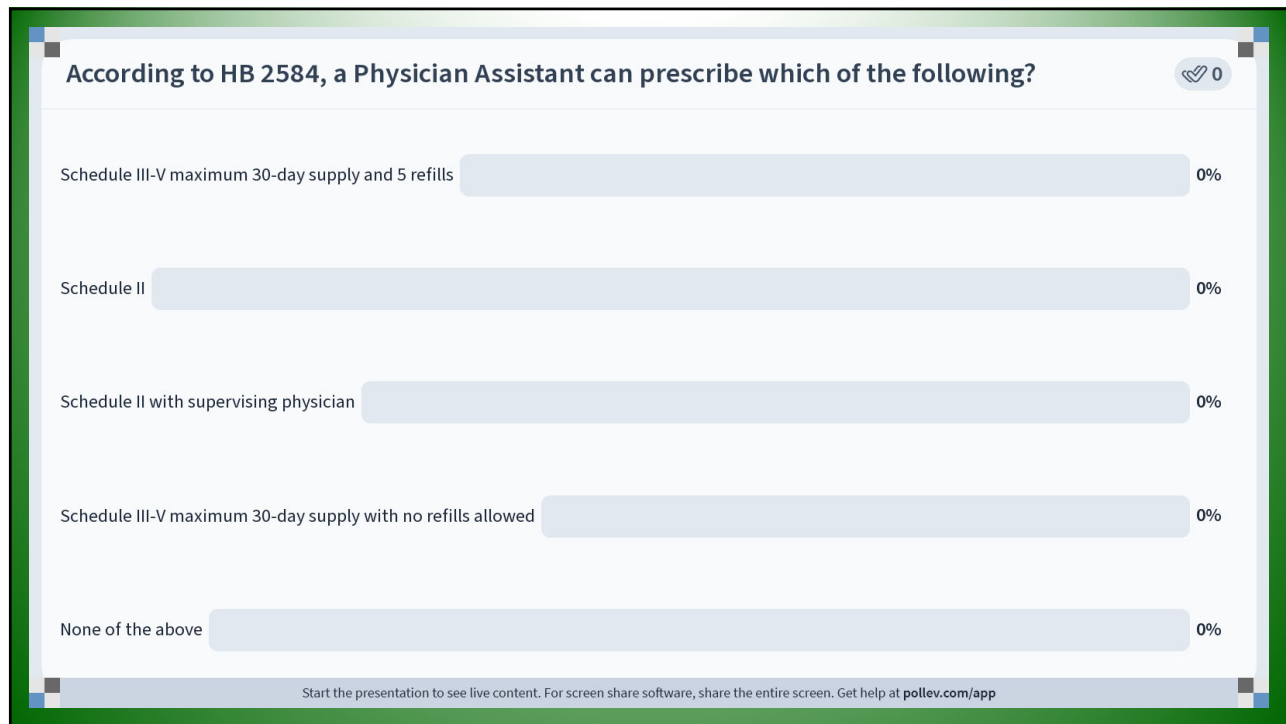

## Oklahoma State Board of Pharmacy FDA Mandated Medication Guides

### Medication Guide:

Patient labeling that is part of the FDA-approved prescription drug labeling for certain prescription drugs when the FDA determines that:

- Patient labeling could help prevent serious adverse reactions.
- Drug has serious risk(s) (relative to benefits) of which patients should be made aware because information concerning the risk(s) could affect patients' decision to use, or to continue to use, the product, or
- Patient adherence to directions for use is crucial to the drug's effectiveness.
- Medication Guides (MGs) are developed by applicants, approved by FDA, and **required to be distributed to patients.**

## Oklahoma State Board of Pharmacy Reporting Fraudulent Prescriptions

- Report to Oklahoma Bureau of Narcotics and Dangerous Drugs (OBNDD) as soon as possible
- Promethazine without Codeine
- Not on official OBNDD prescription pad
- Telephone order
- May accompany a non-CDS prescription to appear legitimate

## Oklahoma State Board of Pharmacy Pharmacy Security

- Effective 09/01/2023
- **OAC 535:15-3-4(8)**: Physical requirements for retail pharmacies
- *Security: There shall be an electronic alarm and video recording system in place to provide protection against theft and diversion.*

### Key Points:


- Routinely check video recording system for malfunctions.
- Is the video recording system continuously recording OR only recording when motion is detected?
- Consider multiple cameras to capture different angles of the same space (ex. front, back, side, and "bird's-eye" view of the filling station).

## Oklahoma State Board of Pharmacy Technician Application and Examination cont.

### OAC 535:15-13-13: Pharmacy technician training

(a) *The pharmacy manager shall be responsible for the development and/or implementation of a pharmacy technician training program.*

(3) *Minimum standards for technician training programs shall be those set out in the Board approved "Pharmacy Technician Training Guidelines".*

(A) Pharmacy technician applicants shall complete Phase I training before they may apply for an Oklahoma Pharmacy Technician permit. A pharmacy technician permit must be received before performing any of the duties of pharmacy technicians authorized in OAC 535:15-5 and 535:15-13.

## Oklahoma State Board of Pharmacy Technician Application and Examination cont.

- Review incorrect exam responses with applicant
- Keep completed exam in training file in the pharmacy
- Readily available for inspections

### E. Pharmacist Review and Training Verification *(supervising pharmacist must sign and date)*

I have reviewed the application as completed by the applicant, including the ***Charges and Convictions***, and I verify that this applicant has met the requirements to become a pharmacy technician and has completed the initial training & exam required by the Board prior to receiving a pharmacy technician permit. I also understand that I am responsible for assuring that this technician remains competent through continuing on-the-job training and that proof of all training must be maintained in the pharmacy and available for inspection.

## Oklahoma State Board of Pharmacy Pharmacy Technician Reinstatement

- **OAC 535:15-13-15:** *Technician reinstatement requirements*
- Applicant who possess an Oklahoma technician permit that was cancelled at request or cancelled for failure to renew.
- Technician permit shall be cancelled 30 days after expiration.
- Revoked technician permit is not eligible for reinstatement without appearing before the Board and receiving permission to apply.
- Must complete a technician reinstatement application.

## Oklahoma State Board of Pharmacy Pharmacy Technician Reinstatement cont.

- Complete Phase I and Phase II training again if technician permit has lapsed for longer than one year.
- Complete pharmacy technician Board exam.
- May complete a new immunization application if immunizing technician does not reinstate immunization permit at the time of reinstatement.
- Expired license/permit does not allow registrant to continue to perform job duties after the expiration date of the license/permit.

## Oklahoma State Board of Pharmacy Pharmacist In Charge (PIC)

- **OAC 535:15-3-2:** Pharmacy responsibilities

**PIC:** *A PIC is designated by his signature on the original pharmacy application or by the appropriate notification to the Board as required in 535:15-3-10(a) and is responsible for all aspects of the operation related to the practice of pharmacy.*



## **Oklahoma State Board of Pharmacy Pharmacist In Charge (PIC) cont.**

PIC responsibilities include but not limited to:

- supervision of all pharmacy employees;
- safekeeping of pharmaceuticals including security provisions when the pharmacy is closed;
- proper record keeping system for the purchase, sale, delivery, possession, storage, and safekeeping of drugs;
- proper display of all licenses;
- annual controlled drug inventory; and,
- maintenance of prescription files.

## Oklahoma State Board of Pharmacy Common Findings In NABP Inspections

NABP's Verified Pharmacy Program (VPP): Multistate and uniform inspection program accepted by state boards of pharmacy across the nation.

- VPP inspections conducted between November 3, 2023-October 31, 2024.
- 213 inspections total (includes nonsterile and/or sterile compounding).
  - Initial competency assessment
  - Ongoing competency assessment
  - Incomplete training records

## Oklahoma State Board of Pharmacy House Bill 1585



- Effective 11/01/2025
- **Title 59 O.S. 353.18B: Pharmacy Technicians**
- *A. Pharmacy technician applicants who are seventeen (17) years of age or older and enrolled in a youth apprenticeship program for pharmacy technicians or a pharmacy technician training program through the Oklahoma Department of Career and Technology Education shall complete Phase II pharmacy technician training in a pharmacy without the requirement to be a pharmacy employee.*
- *All pharmacy technician training programs shall be approved by the Oklahoma State Board of Pharmacy initially and on an annual basis. This permit will only be used for educational purposes for those enrolled in an Oklahoma State Board of Pharmacy-approved program.*
- *B. The youth apprenticeship program for pharmacy technicians and pharmacy technician training programs through the Oklahoma Department of Career and Technology Education shall carry liability insurance on the students in the respective program that covers the student anywhere the student is training in a pharmacy.*

## Oklahoma State Board of Pharmacy Senate Bill 906 Retail Pharmacy Technician Ratio Effective 11/01/2025

- Effective 11/01/2025

**Title 59 O.S. 353.18A: Pharmacy Technicians**

*C. A licensed retail pharmacy shall maintain a pharmacy technician-to-pharmacist ratio of not more than four pharmacy technicians for every one licensed pharmacist.*

Physician Assistants**

- Effective 08/29/2025
- May prescribe Schedule II drugs under a practice agreement on file with the OK Medical Board and supervised delegating physician.
- List of approved Physician Assistants available on OK Medical Board website.

**Oklahoma State Board of Pharmacy  
House Bill 2584  
Physician Assistants cont.**

- May have independent prescribing authority for medical supplies, services, non-scheduled and Schedule III-V without delegating physician supervision after submitting application for review and approval with the OK Medical Board.
- List of Physician Assistants authorized to independently prescribe non-scheduled and Schedule III-V drugs available on OK Medical Board website.

- Schedule III-V for 30-day supply up to 2 refills
- Must be registered with DEA and OBNDD

**Oklahoma State Board of Pharmacy  
House Bill 2298  
Advanced Practice Registered Nurses**

- Effective 11/01/2025
- Advanced Practice Registered Nurse
  - Certified Nurse Practitioner
  - Clinical Nurse Specialist
  - Certified Nurse Midwife
- May have independent prescriptive authority (See Exclusionary Formulary) after application review and approval by the OK Board of Nursing.

**Oklahoma State Board of Pharmacy  
House Bill 2298  
Advanced Practice Registered Nurses cont.**

- No changes to current medications approved to prescribe.
  - Refer to OK Board of Nursing "*Exclusionary Formulary for Advanced Practice Registered Nurses with Prescriptive Authority.*"
  - No Schedule II prescribing
  - May prescribe Schedule III-V with maximum 30-day supply.
- List of Advanced Practice Registered Nurses authorized to independently prescribe is available on the OK Nursing Board website.

**Oklahoma State Board of Pharmacy  
House Bill 2298  
Advanced Practice Registered Nurses cont.**

Independent Prescriptive Authority: Not required to have or list a supervising physician on their prescription; however, must include the following:

- Name, title, address, and telephone number of the Advanced Practice Registered Nurse who is prescribing
- **The notation of "Independent Rx Authority"**
- Name of the client
- Date of the prescription
- Full name of the drug, dosage, route and specific directions for administration
- DEA number of Advanced Practice Registered Nurse, if required
- Written prescriptions shall include the signature of the Advanced Practice Registered Nurse
- Records of all prescriptions will be documented in client records

### **Case Studies**

**March 2019 Arkansas Board of Pharmacy**

- Altered bulk ingredients on compounding logs
- Example of findings
  - Final compounded product#1:
    - 11 bulk ingredients used
    - 2011 original beyond use date for 6 of 11 ingredients
  - Final compounded product#2:
    - 8 bulk ingredients used
    - 2013 original beyond use date for 4 of 8 ingredients

## **Oklahoma State Board of Pharmacy The Ethical Pharmacist cont.**

### **Case Studies**

**March 2019 Arkansas Board of Pharmacy**

- Pharmacist prohibited from compounding
- Fined \$10,000



## **Oklahoma State Board of Pharmacy**

#### **Case Studies**

##### **Arkansas Board of Pharmacy**

- Pharmacist in peer assistance program accessed PDMP for personal use
- Shared PDMP findings
- Felony conviction
- 3 years probation in criminal court
- Board of pharmacy fine \$10,500
- 5 years probation on licensure

## **Oklahoma State Board of Pharmacy**

### **The Ethical Pharmacist cont.**

#### **Case Studies**

##### **BEFORE THE STATE BOARD OF PHARMACY STATE OF OKLAHOMA**

- Pharmacist billed over \$1 million in fraudulent claims to Medicaid and Medicare Part D.
- Patients did not receive medications billed or had a valid prescription for the billed medication.
- Included pediatric and senior patient population.
- Involved high dollar claims.

**Oklahoma State Board of Pharmacy  
The Ethical Pharmacist cont.  
Case Studies**

- Sentenced to 37 months in federal prison (U.S. Attorney's Office, Western District of Oklahoma)
- Restitution of \$328,836.18 to Medicaid
- Restitution of \$753,334.13 to Medicare
- Forfeiture of property
- Revocation of pharmacist license

**OAC 535:25-9-10: Patient health and safety**

*The health and safety of patients shall be a registrant's first consideration*

Handling of misfills:

- Pharmacist on duty vs. technician/auxiliary personnel
